Re: Termination of Duplicative Agreement with AT&T Mobility

Dear Sir:

Because of various AT&T mergers and acquisitions, AT&T Mobility now has duplicative interconnection agreements in effect with your company. In order to clarify the parties' business relationship and to eliminate any confusion or overlap, AT&T Mobility wishes to keep in effect the agreement between Lathrop Telephone Company ("Lathrop") and Cingular Wireless LLC, also on behalf of its wireless affiliates (now doing business as AT&T Mobility) effective April 29, 2005 and to terminate the agreement between Lathrop and Dobson Cellular Systems on behalf of itself and its affiliate American Cellular Corporation, (now doing business as AT&T Mobility) effective January 1, 2007.

Accordingly, AT&T Mobility requests that you sign and return this letter indicating your consent to the immediate termination of the latter agreement identified above (the "Dobson Agreement").

In the event that your company does not consent to such immediate termination, please take this letter as AT&T Mobility's notice of intent to terminate the Dobson Agreement as of December 31, 2011.

Upon termination of the Dobson Agreement, all traffic between your company and Dobson will be exchanged pursuant to the interconnection agreement between Lathrop and Cingular Wireless LLC, also on behalf of its wireless affiliates effective April 29, 2005 (the "Surviving Agreement"). Given the existence of a valid agreement between the parties, there is no need to negotiate a successor agreement.
