The Commission opened this file on July 11, 2018, at the request of Commission's Staff, to assist Staff in its review and consideration of new and existing rules regarding the treatment of affiliate transactions and HVAC (heating, ventilating, and air conditioning) affiliate transactions by and among electrical corporations, gas corporations, heating companies, water corporations with more than 8,000 customer, and sewer corporations with more than 8,000 customers. Several interested stakeholders filed written comments for Staff's consideration. On September 4, Staff filed a motion asking the Commission to notify interested stakeholders of a workshop to further discuss these matters.
