The Commission opened this working case to investigate and consider utility actions related to securing funding from the federal government authorized by the Infrastructure Investment and Jobs Act of 2021 and the Inflation Reduction Act of 2022. In its order opening the case, the Commission directed stakeholders to submit recommendations regarding the date and location of an initial workshop meeting.
