# **2009 SOLAR REQUEST FOR PROPOSALS (RFP)**

- RFP distributed on May 9, 2009 via:
  - Internal 'Solar Contacts' List
  - External 'Power Marketers' Site
    - Subscriber base of approximately 68,000
- Proposals required to provide KCP&L/GMOC ownership of the Solar Renewable Energy Credits (SRECs) associated with the energy
- Responses were due June 15, 2009

# 2009 Solar RFP Respondents

- Respondents included 9 companies with offers varying from central solar to rooftop solar to the purchase of Solar RECs.
- Bids included both ownership and PPA offers.
- Bids were reviewed for least-cost alternatives in developing a short-list, under the assumption the energy and SRECs would have to be 'bundled'.



# **SHORT-LIST REQUEST FOR INFORMATION (RFI)**

- RFI distributed on January 4, 2010, to short-list bidders, requesting the following items:
  - BAFO ("best and final offer")
  - Expected interconnection and delivery
  - Expected annual output (MWhs)
  - Expected in-service date of the facility (COD)
  - A review of our proposed solar PPA form, with a redline version showing all changes and/or exceptions to the form



#### **SHORT-LIST QUALITATIVE ANALYSIS**

- Short-list respondents reviewed on qualitative characteristics, including:
  - Prior Experience
  - Financing
  - Ability to Meet Schedule
  - Panel Availability
  - Technology Maturity
