#### **APPLICATION**

Comes now Missouri Gas Energy, a division of Southern Union Company, ("MGE" or "Applicant"), by and through its counsel, and for its application pursuant to Section 393.170 RSMo and 4 CSR 240-2.060(2) for a certificate of public convenience and necessity, respectfully states as follows:

- 1. Applicant is Missouri Gas Energy, a division of Southern Union Company. MGE's principal office is located at 3420 Broadway, Kansas City, Missouri 64111.
- 2. Southern Union Company is a corporation duly incorporated under the laws of the state of Delaware and conducts business in Missouri under the fictitious name of Missouri Gas Energy. MGE conducts the business of a "gas corporation" and provides natural gas service in the Missouri counties of Andrew, Barry, Barton, Bates, Buchanan, Carroll, Cass, Cedar, Christian, Clay, Clinton, Cooper, Dade, Dekalb, Greene, Henry, Howard, Jackson, Jasper, Johnson, Lafayette, Lawrence, McDonald, Moniteau, Newton, Pettis, Platte, Ray, Saline, Stone, and Vernon, subject to the jurisdiction of the Missouri Public Service Commission (Commission).

- 4. A copy of Applicant's Restated Certificate of Incorporation, fictitious name registration, and Certificate of Authority to do business in the state of Missouri were previously filed with the Commission in Case No. GM-94-40, and are incorporated here by reference.
- 5. Attached hereto and marked as <u>Appendix A</u> is a map of the location of the proposed service area in Newton County, Missouri. It also shows the adjoining areas for which MGE already has a certificate for gas service from the Commission.
- 6. Attached hereto and marked as <u>Appendix B</u> is a metes and bounds legal description of the proposed boundaries of the certificated area in Newton County, consisting of 12 sections.
- 7. Attached hereto and marked as <u>Appendix C</u> is a summary of the plans and specifications for the project including the estimated cost of construction and estimated revenues during the first three years. No particular external financing is anticipated for construction related

to these areas. Construction methods will follow MGE's customary standards and the rules of the Commission.

- 8. Attached hereto and marked as <u>Appendix D</u> is a list of ten persons residing in or who are landowners within the proposed service area.
- 9. The Crossroads Center Distribution and Business Park is currently under development in conjunction with the Industrial Development Authority of the City of Joplin, Missouri (JIDA). JIDA has requested that MGE provide gas service to this developing area which is designed for light manufacturing, distribution and commercial operations. The Crossroads Business Park is located in Jasper County within an area where MGE currently holds a certificate for gas service from the Commission. However, MGE has determined that in order to provide natural gas service to the Crossroads Business Park, the most efficient and economical method would be to construct approximately 3.5 miles of new gas line north from a tap on an interstate pipeline to reach this area. Because MGE does not have a certificate from the Commission for the area between the tap and the Crossroads Business Park through which this new line would be constructed, it is necessary for MGE to obtain the requisite permission from the Commission.
- 10. Applicant will not require any additional franchises or permits from municipalities, counties, or other authorities in connection with the proposed construction other than the usual and customary state highway, railroad and county road permits which will be obtained prior to construction.
- 11. Applicant's existing rates and regulations for natural gas service contained in its tariff, as the same may be allowed to change from time to time pursuant to law, will apply to service in the proposed area.

- 12. The area in which MGE is seeking to be certificated hereby is expected to develop and require natural gas service. Service from a Commission-regulated supplier is not available in these areas at the present time. The construction of this line in order to serve facilities within MGE's existing certificated area may also contribute to future economic development in the proposed area. Since MGE has the ability to provide service in these areas by construction of additions to existing facilities, MGE believes that potential new customers should be afforded the opportunity to take service from MGE if they so desire, pursuant to MGE's extension rule. In addition, this extension will allow MGE to provide natural gas service to new tenants in the Crossroads Business Park, as MGE has been requested to do by JDIA.
  - 13. No gas transmission lines are required to be constructed as a part of this application.

WHEREFORE, Applicant requests an order from the Commission granting it a certificate of convenience and necessity to construct, install, own, operate, control, manage, and maintain a system for the provision of natural gas service to the public pursuant to its approved rates, rules and regulations, in the requested new area of Newton County, Missouri.


