MOTION TO AMEND STAFF RECOMMENDATION TO CONDITIONALLY APPROVE AUTHORITY TO ISSUE SECURED INDEBTEDNESS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and, for its motion to amend Staff's *Recommendation* stating that the Commission conditionally authorize Roy-L Utilities, Inc., to issue up to and including \$73,000 of secured indebtedness, states:

- 1. On February 11, 2014, Staff filed its *Recommendation* that the Commission conditionally authorize Roy-L Utilities, Inc., to issue up to and including \$73,000 of secured indebtedness.
- 2. On February 14, 2014, the Office of the Public Counsel filed a response and objection to Staff's *Recommendation* stating that based on the information provided to OPC, it was concerned that Staff's *Recommendation* may not be based on the terms applicable to the loan approved by HNB National Bank and Roy-L.
- 3. Staff has worked with OPC and Roy-L to clarify the terms of the loan between HNB Bank and Roy-L. Through the assistance of Roy-L's representatives, HNB Bank has provided the parties a letter that describes the terms of the loan to Roy-L that address the concerns of both OPC and Staff.
- 4. Based on the new information provided by HNB Bank on the terms of the loan to Roy-L, Staff files this motion to amend its *Recommendation* to the Commission.
- 5. Roy-L approves of Staff's *Amended Recommendation* and OPC does not object to Staff's *Amended Recommendation*.
 - 6. Furthermore, the parties are in agreement that if this motion is granted, then

the pre-hearing conference scheduled for Tuesday, February 25, 2014 should be canceled.

WHEREFORE, Staff respectfully requests the Commission grant its motion to amend Staff's *Recommendation* based on the new information provided by HNB Bank on the terms of the loan to Roy-L. Additionally, Staff recommends the Commission approve Roy-L's *Application* by March 5, 2014, subject to the conditions stated in Staff's *Amended Recommendation* attached as Appendix A.
