ORDER GRANTING MOTION FOR CLARIFICATION AND CORRECTING ORDER GRANTING ETC DESIGNATION

On June 9, 2022, the Commission issued an order granting Starbeam HSI, LLC's (Starbeam) designation as an Eligible Telecommunications Carrier (ETC) in Missouri for the purpose of receiving federal high-cost and low-income support. In that order, the Commission stated that Staff recommended the Commission approve Starbeam's request for designation as an ETC for the purpose of receiving federal high-cost and low-income support. In fact, Starbeam's application only requested designation for the purpose of federal low-income support, and not for federal high-cost support, and Staff's recommendation only addressed Starbeam's ETC designation for the purpose of federal low-income support.

On June 10, 2022, Staff filed a motion for clarification requesting the Commission to clarify whether it intended to include Starbeam's ETC designation for the purpose of receiving federal high-cost support in its order.

The inclusion of Starbeam's ETC designation for the purpose of receiving federal high-cost support in its order was in error, and the Commission will correct its order accordingly.

THE COMMISSION ORDERS THAT:

1. Ordered Paragraph 1 of the Commission's June 9, 2022 Order Granting Designation as an Eligible Telecommunication's Carrier is corrected to state: "Starbeam's application is granted. Starbeam is granted ETC status for the purpose of receiving federal low-income support statewide."
2. This order shall be effective when issued.
