## ORDER GRANTING ELIGIBLE TELECOMMUNICATIONS CARRIER DESIGNATION IN CERTAIN AREAS

Issue Date: October 19, 2022 Effective Date: November 18, 2022

On August 17, 2022, GTech Fiber, LLC (GTech) filed an application for designation as an Eligible Telecommunications Carrier (ETC) in order to participate in the Lifeline Program and the federal Affordable Connectivity Program. GTech states in its application that it has been awarded funding to build broadband facilities in Missouri in the census blocks listed and the area depicted in Attachment B of its application<sup>1</sup>. GTech requests a Commission order granting ETC designation for that area. GTech is already registered in Missouri as an interconnected voice over internet protocol (IVoIP) provider.

The Commission issued notice and set a deadline for intervention. No parties have intervened in this matter, nor has any party requested a hearing.

The Staff of the Commission (Staff) conducted an investigation and filed its recommendation on September 29, 2022. Staff stated that GTech has met the requirements of Commission Rule 20 CSR 4240-31.016 and recommended the

Commission grant GTech statewide designation as an ETC. On October 7, 2022, responding to a Commission order, Staff clarified that they had inadvertently recommended the Commission grant GTech statewide ETC status and, instead, recommended GTech be granted ETC designation "as requested and outlined in Appendix 'B' of the Company's Application."

Under federal authority, the application is within the Commission's jurisdiction to decide.<sup>2</sup> Since no law requires a hearing, this is a non-contested case.<sup>3</sup> Non-contested cases do not require formal proceedings or hearings before the Commission.<sup>4</sup> Consequently, the Commission bases its decision on the verified filings.

Based upon its review of the verified application, Staff's recommendation and memorandum, and the supplemental filings, the Commission finds that GTech has met the requirements for ETC designation and will approve its application.

#### THE COMMISSION ORDERS THAT:

- 1. GTech Fiber, LLC is granted ETC designation for purposes of participation in the Lifeline Program and Affordable Connectivity Program in census blocks 2006-2010, 2015, 2018, 2019, 2021-2023, 2030-2041, and 2043-2051, as set forth in Appendix B of its application, attached to this order.
  - 2. This order shall become effective on November 18, 2022.
  - 3. This file shall be closed on November 21, 2022.


