Staff shall file its Recommendation no later than April 28, 2023, or in the alternative, no later than April 17, 2023, Staff shall file a motion explaining the good cause why the Commission should petition the Joint Committee on Administrative Rules for an extension of time to respond to the rulemaking petition.
2. Any other person or entity wishing to respond shall do so no later than April 17, 2023.
3. This order shall be effective when issued.
