D/B/A SBC MISSOURI'S NOTICE**

On April 13, 2005, Sage Telecom, Inc. ("Sage"), Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC Missouri") (collectively referred to as "the Parties"), NuVox Communications of Missouri, Inc. ("NuVox"), and the Staff of the Missouri Public Service Commission entered into a Stipulation and Agreement. As part of that Stipulation and Agreement, the Parties agreed to file the Missouri Amendment and the LWC Documents on April 22, 2005. The Parties have attempted to file these documents.
