Union Electric Company d/b/a Ameren Missouri filed a revised tariff on March 7, 2018, as part of its plan to offer a pilot subscriber solar program. That tariff filing was assigned Tariff No. YE-2018-0110. The Commission suspended that tariff until August 4, 2018, to allow time to consider Ameren Missouri's proposal. On May 14, 2018, the parties filed a nonunanimous stipulation and agreement. That stipulation and agreement provided that in approving the stipulation and agreement, the Commission should reject Tariff No. YE-2018-0110. Ameren Missouri would then file an agreed-upon tariff in its place.

An order approving the stipulation and agreement was discussed by the Commission at its June 13, 2018 agenda meeting, but was withdrawn after the Commissioners identified some inconsistencies that the parties agreed to correct. On August 20, 2018, a Second Amended Stipulation and Agreement was filed which also includes a provision that the Commission should reject the tariff filing upon approval of the agreement. Although the Office of the Public Counsel, United for Missouri, and the Missouri Industrial Energy Consumers were not signatories, the agreement states that those parties indicated no opposition to the agreement.

Commission rule 4 CSR 240-2.115(2)(B) allows nonsignatory parties seven days to object to a nonunanimous stipulation and agreement. In order to allow sufficient time for the Commission to consider the nonunanimous stipulation and agreement and issue orders with appropriate effective dates, the Commission will further suspend Tariff No. YE-2018-0110, for an additional ten days.

THE COMMISSION ORDERS THAT:

1. The tariff submitted by Union Electric Company d/b/a Ameren Missouri on March 7, 2018, assigned Tariff No. YE-2018-0110, previously suspended until September 3, 2018, is further suspended until September 13, 2018.

2. This order shall be effective on September 2, 2018.
