## REQUEST FOR WORKSHOP

**COME NOW** the Office of the Public Counsel (“Public Counsel”) and the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for their *Request for Workshop* in this matter hereby state:

1. Public Counsel filed a *Motion to Open a Working Group Regarding a Proposed Residential Customer Disconnection Reporting Rule* on November 25, 2019, which led to a Commission Order opening this docket on December 11, 2019. The Commission Order directed that a workshop meeting regarding this matter shall be held on March 26, 2020.

2. Public Counsel and Staff now ask the Commission to order a workshop be held on Monday, March 30, 2020 from 1:00pm to 4:00pm in Room 450 (Ballroom) of the Governor Office Building at 200 Madison St, Jefferson City, MO 65101. Staff had initially reserved Room 470 on March 26, 2020, for a workshop in this matter, but recognizes that Room 450 (Ballroom) can accommodate more stakeholders.
