ORDER INVITING PARTICIPATION IN CASE STUDY

Issue Date: March 7, 2022

The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. With the Commission's approval, Public Counsel conducted a second workshop meeting on February 25, 2022, to discuss such a rule. On March 4, 2022, Public Counsel filed another revised version of its draft rule and asked the Commission to invite interested utilities to participate in a voluntary one-month case study to test the effectiveness of the latest version of the draft rule proposed by Public Counsel in collecting disconnection data.

Public Counsel explains that participation in its case study is open to those utilities that would be subject to the draft rule, and is voluntary. Public Counsel asks that any utility wishing to participate in the case study submit data responsive to the latest draft rule from the month of April 2022, by no later than May 20, 2022. Public Counsel would treat the submitted data as confidential and would use the information it receives to further revise its draft rule.

THE COMMISSION ORDERS THAT:

1. Any utility wishing to participate in Public Counsel's voluntary case study shall submit data responsive to the draft rule attached to Public Counsel's March 4, 2022

Motion to Establish A Deadline for Participation in a Voluntary One-Month Case Study no later than May 20, 2022.

2. All such submitted data shall be sent to Public Counsel at OPCSERVICE@opc.mo.gov.

3. Public Counsel shall hold all such submitted data as confidential pursuant to Commission Rule 20 CSR 4240-2.135.

4. The Commission's Data Center shall provide a copy of this order to all Missouri investor-owned electric, gas, water, and sewer utilities that serve more than 2,000 residential customers.

5. This order shall be effective when issued.
