## MOTION TO ISSUE ORDER TO SHOW CAUSE

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and submits its *Motion to Issue Order to Show Cause* as follows:

- 1. On September 24, 2008, Mr. Robert B. Hector (Mr. Hector or Complainant) filed a *Complaint* with the Missouri Public Service Commission (the Commission) against Union Electric Company, d/b/a AmerenUE (AmerenUE or the Company).
- 2. On October 3, 2008, the Commission issued its *Notice of Complaint and Order Directing Filing*, ordering AmerenUE to file an answer to Mr. Hector's *Complaint* by November 3, 2008, and directing Staff to conduct an investigation into the *Complaint* and to report its findings no later than December 3, 2008.
- 3. On November 3, 2008, the Company filed its *Answer*, in which it denied the majority of Mr. Hector's allegations, as well as any violation of State statutes, Commission rules, or the Company's tariffs.
- 4. On December 3, 2008, Staff filed its *Staff Recommendation*, in which Staff recommended the Commission either dismiss the *Complaint* in this case or pursue the matter to a preliminary hearing.

- 5. On December 5, 2008, the Commission sent to the Complainant a form upon which to reply to the statements contained in the *Staff Recommendation* filed in the case. Mr. Hector was directed to return the form no later than December 19, 2008.
- 6. On December 22, 2008, the Commission issued its *Order Extending Time*, in which it extended the time in which Mr. Hector had to return the reply form to the Commission. This *Order Extending Time* directed Mr. Hector to complete the form no later than January 13, 2009.
- 7. As of January 21, 2009, Staff has no knowledge of Mr. Hector returning the reply form to the Commission as was directed by the Commission in its *Order Extending Time*.

**WHEREFORE**, Staff motions the Commission to issue an Order to Show Cause, directing Mr. Hector to show cause why his *Complaint* should not be dismissed.
