PETITION FOR LEAVE TO APPEAR *PRO HAC VICE*

COMES NOW Sean R. Brady and hereby petitions the Public Service Commission of the State of Missouri (“PSC” or “Commission”) for leave to appear and participate in the above captioned case as an attorney for Wind on the Wires pursuant to 4 CSR 240-2.040(3)(C) and in conformance with Missouri Supreme Court Rules 6.01(m) and 9.03. In support of this Petition, Sean Brady states as follows:

1. I am an attorney with Wind on the Wires, 570 Asbury Street, Suite 201, St. Paul, MN, 55104. I’ve prepared this affidavit in support of this petition for an Order permitting me to participate in this case *pro hac vice*.
2. I am not a member of the Missouri Bar, however, I am a member in good standing in Illinois, with the Illinois Attorney Registration and Disciplinary Commission of the Supreme Court of Illinois (ARDC) (registration no. 6271134).
