On June 30, 2021, the Staff of the Commission and Union Electric Company d/b/a Ameren Missouri filed a joint request for a two-week extension of time to file agreed upon in-service criteria relating to the Montgomery solar facility. Staff and Ameren Missouri relate that due to personnel unavailability they will be unable to reach a final agreement on the criteria before the current July 2, 2021 deadline. The Commission finds the request reasonable and will grant the extension.

THE COMMISSION ORDERS THAT:

- 1. No later than July 16, 2021, Staff and Ameren Missouri shall jointly file agreed upon in-service criteria for the Montgomery solar facility that will be used to evaluate whether the facility, once operational, meets the fully operational and used for service standard in Section 393.135, RSMo.
