# ORDER GRANTING PUBLIC COUNSEL'S MOTION FOR AN EXTENSION OF TIME TO RESPOND TO STAFF'S RECOMMENDATION

On January 11, 2022, the Commission directed its Staff (Staff) to file a recommendation concerning Evergy Missouri Metro and Evergy Missouri West's (Evergy) application to construct a solar facility. The Commission set a deadline of March 21, 2022, for any responses to Staff's recommendation or Evergy's application.

On March 21, 2022, the Office of the Public Counsel (OPC) filed a motion requesting an extension of time to respond to Staff's recommendation or, in the alternative, set a hearing. In support of its motion OPC states that, due to overlapping issues with Evergy's pending general rate case, OPC needs additional time to respond. The Commission will grant OPC's motion.

1. OPC's motion for an extension of time is granted. OPC shall file its response to Staff's recommendation and Evergy's application no later than April 7, 2022. 2. This order is effective when issued.
