2. Each party shall prepare a list of its pre-filed, pre-marked exhibits and file a copy of that list in the Commission's Electronic Filing Information System (EFIS). Exhibits offered during cross-examination, but which have not been pre-filed, need not be included

on the list. However, when those documents are offered during the hearing, they will be assigned a number from that party's number group.

3. This order is effective when issued.
