ORDER GRANTING STAY OF PROCEEDINGS

Issue Date: May 10, 2023 Effective Date: May 10, 2023

On February 14, 2023, The Empire District Electric Company d/b/a Liberty filed an application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) authorizing Liberty to construct, install, own, operate, maintain, and otherwise control and manage two combustion turbine generators to replace existing combustion turbine generators Riverton Unit 10 and Riverton Unit 11.

On February 16, 2023, the Commission issued an *Order Directing Notice, Setting Intervention and Response Deadlines, and Directing Staff Recommendation*, which, among other things, set an April 3rd deadline for the Staff of the Commission (Staff) to file a recommendation or a status report stating when it expects to file a recommendation.

On April 3, 2023, Staff filed its *Status Report* and proposed a May 3, 2023, deadline for Staff to file its recommendation on Liberty's CCN application or to file a joint procedural schedule from the parties, if appropriate. On April 26, 2023, the Commission issued an *Order Granting Extension of Time* in which it set May 10, 2023, as the deadline for Staff to file its recommendation on Liberty's CCN application or, in lieu of a recommendation, a joint procedural schedule on behalf of all parties.

On May 9, 2023, Liberty filed a *Motion for Stay of Proceedings* to allow Liberty time to address additional developments regarding the generation interconnection process with the Southwest Power Pool and to provide additional information to Staff and other parties regarding the details of the proposed project. Liberty proposes to provide monthly status reports during the pendency of the stay. Liberty also requests that the Commission relieve Staff of its current obligation to file a recommendation or joint procedural schedule during the pendency of the stay.

The Commission will grant Liberty's motion.

THE COMMISSION ORDERS THAT:

- 1. The proceedings in this matter are stayed until further notice by the Commission.
- 2. During the stay, Staff is relieved of its obligation to file a recommendation or joint procedural schedule, as previously ordered by the Commission.
 - 3. Liberty shall provide monthly status reports beginning on June 15, 2023.
 - 4. This order shall be effective when issued.
