Dear Customer:

On March 30, 2011, the Missouri Public Service Commission (Commission) approved an increase in the annual water operating revenues of Whiteside Hidden Acres, LLC (Company), under the provisions of the Commission's small utility rate case procedure. The Commission has decided an increase of \$7,464 in the Company's annual water operating revenues is warranted, effective April 11, 2011. Set out at the end of this notice is a table that summarizes the approved revisions to the Company's rates that includes a quarterly bill comparison for a residential customer using 13,500 gallons of water.
