In the Stipulation and Agreement entered into by New Florence Telephone Company and the other parties in Case No. TC-2006-0184, one of the requirements found in Paragraph III(D) was that New Florence revise its 2005 Annual Report to include a statement regarding the corrections contained in the report relative to inaccuracies contained in the 2001-2004 reports.
