This file opened on November 10, 2022, when the Office of the Public Counsel filed a motion asking the Commission to open a working case to investigate and consider utility actions related to securing funding from the federal government authorized by the Infrastructure Investment and Jobs Act of 2021 and the Inflation Reduction Act of 2022. Before ruling on Public Counsel’s motion, the Commission will direct its Staff to respond to that motion, and will offer interested stakeholders an opportunity to respond.

THE COMMISSION ORDERS THAT:

1. The Commission’s Staff shall respond to Public Counsel’s motion to open a working case by November 22, 2022.
2. Any other stakeholder wishing to respond to Public Counsel’s motion to open a working case shall do so by November 22, 2022
3. This order shall be effective when issued.
