The Commission has undertaken this rulemaking to adopt a rule regarding service disconnection reporting requirements for electric, gas, sewer, and water utilities. This proposed rule ensures that available information about customer disconnections is accurate and consistent.

The Commission finds that the rule is necessary to protect the public interest and to carry out the purposes of the statute that granted the rulemaking authority. This rule was developed with input from interested stakeholders through Commission file number AW-2020-0148, and the Commission will seek further comments from interested stakeholders during the rulemaking process

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed rule with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.
