

**APPLICATION TO CANCEL
CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW Axon Telecom, L.L.C. ("Axon"), through its undersigned counsel, and pursuant to 4 CSR 240-2.060 and § 392.410(5), RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariff. In support of its Application, Axon states as follows:

1. Axon is a Kentucky corporation with principal offices located at 9133 U.S. Highway 60 West, Sturgis, Kentucky 42459. The Commission issued Axon a Certificate of Service Authority to provide intrastate interexchange telecommunications services within the state of Missouri in Case No. TA-2000-156 (September 24, 1999).

2. Axon's certificate of authority to do business from the Missouri secretary of state were provided in Case No. TA-2000-156. Pursuant to 4 CSR 240-2.060(G), Axon requests that the certificate be incorporated by reference herein.

3. Axon does not currently have any customers in the state of Missouri and, as its business plans have changed, Axon no longer intends to provide telecommunications service in Missouri. Accordingly, Axon does not have to notify anyone regarding discontinuance of service in Missouri.

4. Axon does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or

rates, which action, judgment or decision has occurred within three (3) years of the date of the application. AXON does not, to the best of its knowledge, have any overdue annual reports or assessment fees.

6. Cancellation of Axon's Certificate of Service Authority and tariffs is not detrimental to the public interest. The public will not be harmed by Axon's withdrawal because, as stated above, Axon does not provide any telecommunications services to customers in Missouri, and thus, no customers will be affected. Furthermore, there are many other alternative

telecommunications providers from whom Missouri residents can purchase interexchange telecommunications services.

WHEREFORE, Axon Telecom, L.L.C. respectfully requests the Commission to issue an order canceling its certificate of service authority and tariffs and granting such other relief as is reasonable in the circumstances.


