



1 **Q. Please state your name and business address.**

2 A. My name is Richard A. Baudino. My business address is J. Kennedy and Associates,  
3 Inc., 570 Colonial Park Drive, Suite 305, Roswell, Georgia 30075.

5 **Q. Did you submit testimony previously in this proceeding?**

6 A. Yes. I submitted Direct and Rebuttal Testimony on behalf of The Commercial  
7 Group.

9 **Q. What is the purpose of your testimony?**

10 A. The purpose of my Surrebuttal Testimony is to address the Rebuttal Testimony of  
11 Mr. Wilbon D. Cooper, witness for AmerenUE (“Ameren” or “Company”). My  
12 testimony will also generally address the area of revenue allocation to customer  
13 classes.

1 **Q. On page 10 of his Rebuttal Testimony, Mr. Cooper maintained his**  
2 **recommendation that the Commission adopt an across-the-board (“ATB”)**  
3 **increase for all customer classes. Please address this portion of Mr. Cooper’s**  
4 **testimony.**

5 A. Mr. Cooper did not present any new evidence or support for the reasonableness of an  
6 ATB increase. The cost of service studies still show that the Large General Service  
7 and Small Primary Service classes should receive increases that are lower than the  
8 system average. Nothing in Mr. Cooper’s Rebuttal Testimony changes my original  
9 recommendations to the Commission regarding class revenue allocations, which  
10 should be based on the results of the Company’s class cost of service study.

12 **Q. Did the other parties present any new evidence or support for an ATB increase**  
13 **in their Rebuttal Testimonies?**
