APPLICATION OF UNION ELECTRIC COMPANY d/b/a AMERENUE TO INTERVENE

COMES NOW Union Electric Company, d/b/a AmerenUE ("AmerenUE"), by and through its counsel, and pursuant to Rule 4 CSR 240-2.075 of the Public Service Commission of Missouri ("Commission"), asks leave to intervene in this proceeding. In support of its Application To Intervene, AmerenUE states as follows:

- 1. AmerenUE is a corporation duly organized and existing under the laws of the State of Missouri, with its principal office located at 1901 Chouteau Avenue, St. Louis, Missouri 63103, and is an electrical corporation, gas corporation, and public utility as defined in Section 386.020, RSMo. (2000). AmerenUE is engaged in providing electric and gas service in portions of Missouri as a public utility under the jurisdiction of the Commission. AmerenUE is also engaged in providing electric and gas service in portions of Illinois.
- 2. On January 13, 2003, Southern Union Company filed an application with Missouri Public Service Commission seeking authority to purchase the equity interests of Panhandle Eastern Pipeline Company ("Panhandle"), including various subsidiaries involved in natural gas transportation and storage services in the Midwest. On January 16, 2003 the Commission issued an Order Providing Notice, Establishing Time for Intervention, Scheduling a

Prehearing Conference, and Relieving Staff and other Parties of the Obligation to File a Recommendation by February 3, 2003. In its order, the Commission required requests for intervention in this proceeding to be filed no later than January 24, 2003.

- 3. AmerenUE purchases natural gas transportation and storage services from Panhandle, and AmerenUE has an interest in ensuring that Panhandle will continue to provide it reliable service at reasonable rates. As a consequence, AmerenUE will or may be directly impacted by the outcome of this proceeding. AmerenUE's interest in this matter is different from that of the general public and cannot be represented adequately by any other party to this proceeding. Therefore, AmerenUE seeks intervention.
- 4. At this point, AmerenUE is unsure of the position it will be taking on any issues that may come before the Commission in this case.

WHEREFORE, based upon the foregoing, AmerenUE requests that the Commission grant this Application To Intervene and allow AmerenUE to participate fully in all proceedings in this case with all rights and privileges accorded to a party.
