## **STATUS REPORT**

- 1. At the prehearing conference, MAWC discussed with Staff a form of report that MAWC was working on in order to provide the information that is the subject of MAWC's Motion for Waiver/Variance ("number of bills issued outside the 26-35 day period for monthly billed customers and no more than 100 days for a quarterly billed customer").
- 2. MAWC has since confirmed its ability to produce information in the proposed form beginning with May 2013. MAWC has today provided to Staff and the Office of the Public Counsel (Public Counsel) the report for May 2013. MAWC will be able to provide Staff and Public Counsel with the reports for June 2013 through March 2014.
- 3. Accordingly, in order for this process to be completed, MAWC requests that the Commission provide it an additional two weeks (or until May 13. 2014) to file a second status report concerning whether a resolution has been reached or, in the alternative, a hearing date will be necessary.
