**Complainant Michele Westmoreland's  
Second Motion to Extend the Deadline for a Pre-Hearing Conference By Consent**

Comes now Complainant Michele Westmoreland and for her Second Motion to Extend the Deadline for scheduling a Pre-Hearing Conference states as follows:

1. Complainant Michele Westmoreland seeks recompense from Missouri American Water Co. and its insurer, Travelers Insurance Co., for water damage to her home in St. Louis County, MO, sustained on or about December 3, 2013.

2. In its Order dated April 21, 2015, the MO Public Service Commission granted Complainant's First Motion for Additional Time, awarding 10 more days or until May 4, 2015 for the parties to try to resolve their differences.

3. Complainant is diligently working to secure estimates and appraisals in her efforts to resolve this matter. Complainant's efforts were explained to Mr. Timothy Luft, Counsel for MO American Water; Peter D. Muzik of Travelers Insurance Co. and Cydney Mayfield, Senior Counsel for the MO Public Service Commission. After being so apprised, counsel for Complainant asked each of the three whether he could represent, via this Motion, that he spoke with each of them, explained the progress and would they consent to an additional 20 days' extension (or until Monday, May 25, 2015) to attempt to settle the matter. All agreed that their consent to an extension could be so represented to the PSC.

4. If granted, Complainant will have received 30 days' total extension to try to settle the matter.

WHEREFORE, with the consent of the three other parties, Complainant Michele Westmoreland moves for an additional 20 days or until Monday, May 25, 2015 to submit exclusionary dates for a Pre-Hearing Date and Schedule and for such other and further relief as be meet and proper in the premises.
