Dear Secretary Morris L. Woodruff:

This letter is to notify you, in accordance with Section 67.2701 of the Missouri Revised Statutes (Cum. Supp. 2010) ("RSMo), that as of July 31, 2021, Southwestern Bell Telephone Company d/b/a AT&T Missouri has completed the transfer of its Missouri Video Service Authorization to its affiliate, DIRECTV, LLC. The transfer took place in connection with AT&T's transfer of its multichannel video distribution businesses, including the U-verse IP-enabled video service, to a new affiliate in which AT&T retains a majority economic interest, with TPG Capital holding a minority economic interest. As specified in RSMo § 67.2701, AT&T Missouri is providing a copy of a transfer notice to each affected political subdivision.

DIRECTV, LLC will continue to provide the U-verse IP-enabled video service pursuant to, and be bound by, the applicable Missouri statutes. The residents of Missouri will continue to receive the same high quality service that they enjoy today without need for any additional action on their part.

Attached is an affidavit executed by a DIRECTV, LLC officer with the information and affirmations required by RSMo § 67.2679(7).

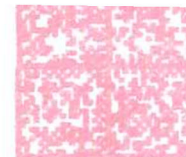
