COMES NOW United For Missouri, Inc. ("UFM"), by and through its counsel, pursuant to Commission Rule 4 CSR 240-2.075, and respectfully applies to intervene as a party in the above referenced case. In support of this Application, UFM states as follows:

- 1. UFM is a nonprofit mutual benefit corporation organized under the laws of the state of Missouri. Formed in July 2010, UFM has over 80,000 members and is committed to serving its members by supporting economic policies in the state that will achieve growth, opportunity and prosperity.
- 2. UFM's interest is different than the interest of the general public and may be adversely affected by a final order in this case. UFM's intervention and participation in this proceeding will serve the public interest in that it will assist the Commission in developing the record for decision in this case.
- 3. UFM has not yet taken a position in this case but reserves the right to take a position on specific issues later.
- 4. There is good cause to grant this application to intervene in that the Commission rules pertaining to the integrated resource planning process grant "stakeholders" and not parties a right to participate in the stakeholder process. UFM had no expectation that it was required to

seek intervention in order to participate in the stakeholder process. However, the Commission's rules on confidential information address treatment of proprietary and highly confidential information by parties. UFM seeks party status in order to review highly confidential

information in accordance with the Commission's rules.

5. No other stakeholder has sought intervention in this proceeding and the

Commission has not issued any orders regarding intervention. Kansas City Power & Light

Company and KCP&L Greater Missouri Operations Company have scheduled a stakeholder

meeting, in which UFM intends to participate, for Tuesday April 26, 2016. UFM will accept the

record in this case as it stands and accept the procedures as dictated by Commission rule.

WHEREFORE, for the foregoing reasons, United for Missouri respectfully requests the

Commission grant its Application to Intervene in this matter.
