## AT&T MISSOURI'S MOTION TO CANCEL PAYPHONE CERTIFICATE OF SERVICE AUTHORITY

AT&T Missouri<sup>1</sup> respectfully moves the Commission<sup>2</sup> to issue an order canceling AT&T Missouri's certificate of service authority to provide private pay telephone service in Missouri. In support of its Motion, AT&T Missouri states:

1. On July 21, 1997, the Commission granted a certificate of service authority to

AT&T Missouri to provide private pay telephone service in Missouri in Case No. TA-97-544.

2. AT&T Missouri no longer provides private pay telephone service in Missouri and

wishes that its certificate of service authority to provide that specific service be cancelled.

3. The Commission has the authority to cancel a telecommunications certificate

pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

WHEREFORE, AT&T Missouri respectfully requests the Commission to cancel the certificate of service authority previously issued to AT&T Missouri to provide private pay telephone service in Missouri.
