
On August 26, 2011, Missouri-American Water Company (MAWC or Company) filed revised tariff sheets, the purpose of which was to implement a consolidated water tariff (rules and regulations, certificated areas and appendices, only) for a number of its Districts. This consolidated tariff filing was the result of several Collaboratives that were created as part of the settlement of the Company's last rate case (WR-2010-0131). These revised tariff sheets had a proposed effective date of October 1, 2011.

After review of the filing, Staff found a number of typographical and format changes that it suggested be made. The Company is in the process of making those changes and anticipates filing substitute tariff sheets in the next day or so. In order to allow sufficient time to prepare and file the substitute tariff sheets, for Staff to review same and for the Commission to then consider the matter, MAWC voluntarily extends the proposed effective date of all of the subject tariff sheets from October 1 to October 15, 2011.
