COMES NOW Trigen-Kansas City Energy Corporation (“Trigen”), through the undersigned counsel, and for this Compliance Filing respectfully states as follows:

1. In its Report and Order issued in this case on May 25, 2006 (the “Order”), the Commission granted Trigen’s application for a certificate of convenience and necessity as set forth in the Order.
2. Ordered Paragraph 3 of the Order stated that “This Certificate is conditioned upon Truman Medical Center funding the cost of construction for the proposed extension of Trigen’s facilities to serve Truman Medical Center.”
3. Ordered Paragraph 4 of the Order stated that “Trigen-Kansas City Energy Corp. and Truman Medical Center shall file a written agreement setting forth the details of their construction and funding plans for the project, as well as their agreement regarding the mechanism for any refund to Truman for advancing construction costs.”
4. Pursuant to Ordered Paragraph 4 of the Order as set forth above, attached hereto for filing with the Commission are copies of two **Highly Confidential** agreements. The attached agreements are designated as **Highly Confidential** under the

provisions of the protective order previously issued for this case and under the provisions of 4 CSR 240-2.135 since they are customer-specific and contain market specific information relating to goods or services purchased or acquired for use by a company in providing service to customers.

WHEREFORE, Trigen respectfully requests that the Commission receive the attached for filing as full compliance with the Commission's Report and Order issued May 25, 2006.
