**COMPLIANCE FILING OF INFORMATION REQUIRED  
BY REPORT AND ORDER**

COMES NOW Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") (collectively, the "Company"), by and through counsel and, in compliance with Ordering Paragraph 7 on page 67 of the Commission's *Report and Order* issued in above-captioned cases hereby files the information required by Section 393.275.1, RSMo. and Commission Rule 4 CSR 240-10.060. The Company states as follows respecting this compliance filing:

1. Section 393.275.1, RSMo. requires the Commission to provide notice and certain information to municipalities whenever the Commission approves a rate increase of more than 7%. Commission Rule 4 CSR 240-10.060 requires the utility to provide certain information to the Commission so that the Commission can discharge its statutory obligations.

2. On January 9, 2013, the Commission issued the *Report and Order*, which authorized an increase over 7%,<sup>1</sup> thus triggering application of the above-referenced statute and rule.

<sup>1</sup> Customers in the MPS rate jurisdiction in GMO received a 4.9% increase.

3. The *Report and Order* directed the Company to file the information required by the above-referenced statute and rule no later than February 5, 2013.

4. Attached hereto as Exhibit A is the information required by the statute and the rule.

WHEREFORE, the Company requests that the Commission accept this information in compliance with the directive contained in the *Report and Order*.
