THIRD SUPPLEMENTAL INFORMATION AND VERIFICATION OF GOSEMO, LLC FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

On September 27, 2018 GoSEMO, LLC ("GoSEMO"), by its undersigned counsel submitted its Application for Designation as an Eligible Telecommunications Carrier ("ETC") in the State of Missouri ("Application"). On November 5, 2018, GoSEMO received an email from the Missouri Public Service Commission Staff Counsel Department with a request for clarification or additional information to be provided. Staff's request and GoSEMO's response to Staff's request follows:

1. The supplement filed October 24th states GoSEMO relies on the third party IVoIP provider, Momentum Telecom Inc., to provide voice service to its customers. Momentum Telecom Inc. doesn't appear to be registered as an IVoIP provider with the MoPSC. Our records indicate Momentum Telecom Inc. was previously certificated to provide basic local and interexchange services, however those certificates were cancelled in 2014. Please explain.

GoSEMO was unaware until this email from Staff on November 5, 2018 that

Momentum Telecom, Inc. was not a certificated IVoIP provider in the State of Missouri.

On November 14, 2018, GoSEMO filed it's Application for registration to provide

Interconnected Voice over Internet Protocol service in exchanges statewide in the State of

Missouri along with a Motion for Expedited Treatment in Case No. DA-2019-0145. The

Commission granted said Application on November 15, 2018. The Commission's Order

grants GoSEMO, LLC authority to provide Interconnected Voice over Internet Protocol

service effective on November 25, 2018. Therefore, GoSEMO will not be using Momentum Telecom, Inc. to provide certificated Interconnected Voice over Internet Protocol service to GoSEMO's customers as previously indicated in GoSEMO's Second Supplemental Information and Verification.
