**Additional Information:** On April 6, 2009 MAWC made a repair at 11139 Larimore Ave. I believe this makes the third time I have seen MAWC repairing the brand new water main installed on the north side of Larimore Ave. in I believe 2006-2007 This makes the sixth MAWC repair (that I know of) near my home since approximately July of 2008. I believe the repair records would reveal several more.

As of today April 10, 2009 water continues to flow into my basement and the sump pump runs approximately every ten minutes. This problem still persists with little or no change.

As I do not know the process, I really do not have an opinion as to whether the complaints need to be combined or severed into separate contested cases. I am for what ever will produce the fastest results to addressing/repairing each individual problem at each location in my neighborhood. I trust that the Public Service Commission Judges will make decisions in the best interest of resolving this water problem (where ever it is coming from) as quickly as possible so I can remediate the toxic mold in my basement and hopefully recover from the serious illness caused from this mold.
