### **FIRST ADDENDUM TO INTERCONNECTION AGREEMENT**

#### **Mutually Acceptable Connection Locations**

Pursuant to Section 4 (Direct Connection) of the First Addendum to Interconnection Agreement, the Parties hereby agree to establish the following connection locations. These points of interconnection (POIs) are agreed to by and between the Parties as being “mutually acceptable” within the meaning of subsection (c) of Section 4.

Additional Future Points of Interconnection:

Additional Points of Interconnection will be established at CenturyTel Central Offices to the extent that the exchange of traffic between the Parties reaches a DS-1 trunk equivalency. A DS-1 equivalency will be deemed reached when traffic studies of average busy hour CCS indicate that the number of trunks necessary to achieve a .001 Grade of Service based upon application of the Erlang B table is equal to or exceeds 24 for three consecutive months.

Traffic Studies:

CenturyTel will conduct traffic studies for exchange of traffic at all CenturyTel Central Offices listed above in this Attachment. With respect to the Rockaway Beach central office, traffic studies will begin July 1, 2005. With respect to all other CenturyTel Central Offices listed above, traffic studies will begin September 1, 2005.
