## ORDER SETTING PREHEARING CONFERENCE

On September 15, 2017, Dora Middleton filed a formal complaint against Union Electric Company, d/b/a Ameren Missouri. After notice was issued, Ameren Missouri filed its *Answer* on October 18, 2017. The Staff of the Missouri Public Service Commission (Staff) was directed to investigate and respond. On November 2, 2017, Staff filed a report recommending that the Commission set a prehearing conference to discuss the case further. At the Commission's request, Staff provided available dates for a prehearing conference.

Having received the complaint, the answer, and Staff's report, this matter is ready to be set for hearing. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on January 24, 2018, at 10:00 a.m. Failure to appear at the conference without being

excused may result in a default being issued in accordance with Commission Rule 4 CSR 240-2.090(5).

2. The prehearing conference will convene in Room 209 of the Spencer Road Library Branch, 427 Spencer Road, St. Peters, MO 63376. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. Such contact shall be through the Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711.

3. This order shall be effective when issued.


