#### ORDER SETTING PREHEARING CONFERENCE

On October 23, 2017, Gene Edward Dudley filed a formal complaint against Kansas City Power & Light Company ("KCP&L"). After notice was issued, KCP&L filed its *Answer and Motion to Dismiss of Kansas City Power & Light Company,* on November 22, 2017. The Staff of the Missouri Public Service Commission ("Staff") was directed to investigate and respond. On December 28, 2017, Staff filed a report that found KCP&L had not violated any applicable statutes, Commission Rules, or Commission-approved Company tariffs.

Having received the complaint, the answer, and the Staff's report, this matter is ready to be set for hearing. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference. In addition, for the convenience of the parties, they may appear by telephone as set out below.

#### THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on January 18, 2018 at 11:00 a.m. Failure to appear at the conference without being

excused may result in a default being issued in accordance with Commission Rule 4 CSR 240-2.090(5).

- 2. The prehearing conference will convene in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act.
