ORDER GRANTING EXTENSION

On January 18, 2022, Complainant filed a Complaint in this matter as a result of a power outage, and the Commission issued an order directing the Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) to file an answer to the Complaint no later than February 7, 2022. On February 7, 2022, Ameren Missouri filed a request for extension of twenty days to file its answer, stating that the parties wish to settle and intend to dismiss the matter. Ameren Missouri also requests relief from deadlines for response to data requests by the Commission's Staff.

The Commission finds Ameren Missouri's requests to be reasonable and will grant them.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri is granted a deadline extension for filing its answer to the Complaint and responses to Staff's data requests in this matter.
2. Ameren Missouri shall file its answer to the Complaint and responses to data requests no later than February 27, 2022.

3. This order shall be effective when issued.
