On April 19, 2022, Glory Pittsenbarger filed a complaint against The Empire District Electric Company d/b/a Liberty (Liberty). The Commission also issued its Order Giving Notice of Case Filing, Directing an Answer, and Directing a Staff Investigation on the same date. Liberty filed its Answer to the complaint on May 19, 2022, and on June 3, 2022, the Commission's Staff filed a Staff Report describing the results of its investigation.
