1 JUDGE PRIDGIN: Good morning. We're on the
2 record. This is a prehearing conference in Case
3 No. EC-2010-0276, Brian L. White v. Union Electric Company,
4 d/b/a AmerenUE. I am Ron Pridgin. I'm the Regulatory Law
5 Judge assigned to preside over this prehearing conference.
6 It's being held on June 22, 2010 in the Governor Office
7 Building, Jefferson City, Missouri. The prehearing
8 conference was scheduled for 10:00 a.m. It is beginning at
9 roughly 10:08 a.m. I delayed on purpose just to see if we
10 had the complainant either show up by phone or in person
11 and I've not noticed his appearance, but let me take
12 entries of appearance just to make sure I'm not missing
13 something.

14 Could I get an entry of appearance from the
15 Staff of the Commission, please?

16 MR. RITCHIE: Thank you, Judge.
17 Representing the Staff of the Missouri Public Service
18 Commission, Sam Ritchie, PO Box 360, Jefferson City,
19 Missouri 65102.

20 JUDGE PRIDGIN: Mr. Ritchie, thank you.
21 Entry of appearance on behalf of AmerenUE,
22 please.

23 MS. GIBONEY: Sarah Giboney, Smith Lewis,
24 111 South Ninth Street, Columbia, Missouri 65201, for
25 AmerenUE.

1 JUDGE PRIDGIN: Ms. Giboney, thank you.

2 Is there either in person or by counsel for
3 Brian L. White? Hearing none, Mr. White does not appear.

4 Any entry of appearance for the Office of
5 Public Counsel? Hearing none, the Office of Public Counsel
6 does not appear.

7 Is there anyone else wishing to enter an
8 appearance.

9 MS. HART: I will. My name is Cathy Hart.
10 I'm with AmerenUE, 101 Madison, Jefferson City, Missouri.

11 JUDGE PRIDGIN: All right. Ms Hart, thank
12 you very much.

13 I hold these prehearing conferences routine
14 with these cases to try to get the parties together to
15 discuss settlement and also to discuss possible procedural
16 schedules. I realize that's probably going to be a little
17 difficult without Mr. White here. And so I will conclude
18 the on-the-record portion of the prehearing conference in
19 just a moment and leave the phone bridge open if Ameren and
20 Staff want to speak and if you want to try to contact
21 Mr. White or not. That's up to you.

22 Is there anything else that the parties want
23 to bring to my attention before we go off the record?

24 MS. GIBONEY: Judge Pridgin, is there
25 anything you'd like us to follow-up with, given that

1 Mr. White does not appear? Sometimes I -- there will be
2 orders to show cause and sometimes I think we file motions
3 for those?

4 JUDGE PRIDGIN: That's certainly up to you.
5 I would prefer, for my record, so that if you want an order
6 to show cause that you -- that you file a motion because
7 sometimes -- you know, I don't know -- maybe he's five, ten
8 minutes late and he calls and -- and you know, you're able
9 to speak and proceed.

10 MS. GIBONEY: Okay.

11 JUDGE PRIDGIN: But if that's something that
12 you want from me, if you'd file a motion for it and you
13 know, allege in there whether he showed up or not and what
14 relief you want, that's something I would normally have o
15 problem granting, having him explain why he didn't appear.

16 MS. GIBONEY: Thank you.

17 JUDGE PRIDGIN: You're welcome. Anything
18 else?

19 All right. If I could ask the parties to
20 stay on the line, that will conclude the on-the-record
21 prehearing conference in Case No. EC-2010-0276. Thank you
22 very much. We're off the record.
