

WHOLESALE SERVICES

DEFINITIONS

Commission - Refers to the Missouri Public Service Commission.

Company - Corban Communications, Inc., issuer of this tariff.

Customer - The person, firm, corporation, governmental unit or other entity (including the successors and assigns of such entities) which orders Service and which is responsible for the payment of charges.

End Users - Telecommunications companies with which Corban Communications, Inc. contracts to provide telecommunications services.

Wholesale Service - Services made available by the Company pursuant to this tariff.

WHOLESALE SERVICES RATES AND CHARGES

1. Services:

A. Private Line Service ICB

B. There are no retail services offered pursuant to this tariff.

2 Special Pricing Arrangements – Individual Case Basis (ICB)

Private line services will be made available to customers in a nondiscriminatory manner. Rates for interexchange and local exchange dedicated access, private line, non-switched services will be determined on an Individual Case Basis (ICB). The ICB rates will be structured to recover the Company's cost of providing the service and will be made available to the Commission Staff upon request on a proprietary basis. ICB rates will not be used for switched services.
