CORRECTION OF DEFICIENCY AND REQUEST FOR APPROVAL

COME NOW GTE Midwest Incorporated and GTE Arkansas Incorporated ("GTE") and Nextel West Corp. d/b/a Nextel Communications or Nextel ("Nextel") and hereby file this Correction of Deficiency and Request for Approval and would respectfully show the Missouri Public Service Commission (the "Commission") the following:

1. On October 20, 1997, the Commission issued its Order Rejecting Interconnection Agreement in this docket. The Order became effective on October 27, 1997.
2. The Commission's Order stated that the case would remain open for thirty days from the effective date to consider approval of the interconnection agreement if Nextel filed a pleading within that time which specified the legal name of the company and which provides evidence of the registration of any fictitious name with the Missouri Secretary of State, in compliance with 4 C.S.R. 240-2.060(1)(A).
3. In executing the interconnection agreement, Nextel erroneously listed its corporate name in Missouri as Dial Call, Inc. Its actual name at the time was OneComm Corporation, N.A.. Nextel has changed its corporate name in Missouri from OneComm Corporation, N.A. to Nextel West Corp. On September 22, 1997, Nextel West Corp. received a

certificate of amendment of authority of a foreign corporation in Missouri. Said certificate is attached hereto as Exhibit 1.

4. To reflect the correction of Nextel's corporate name, GTE and Nextel have executed an Amendment to Interconnection Agreement in the State of Missouri. The Amendment is attached hereto as Exhibit 2.


5. On October 22, 1997, Nextel West Corp. filed its registration of fictitious name for the names Nextel and Nextel Communications. Said registrations are attached hereto as Exhibit 3.

6. By this pleading, Nextel has specified the legal name of its company and provided evidence of the registration of all fictitious names with the Missouri Secretary of State. Therefore, Nextel has corrected the deficiency found by the Commission in its October 20 Order.

WHEREFORE, for the foregoing reasons, GTE and Nextel respectfully request that the Commission approve their interconnection agreement, as amended.



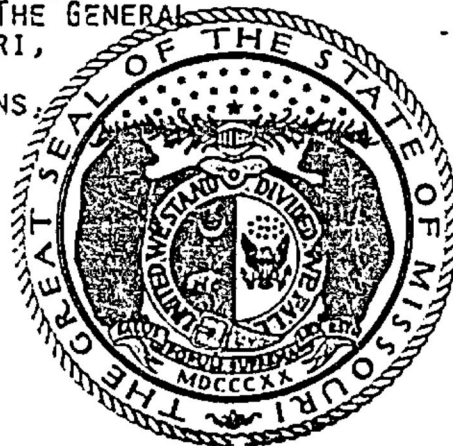


