Dear Ms. Dale:

On August 6, 2008, The Empire District Electric Company ("Empire") submitted compliance tariff sheets pursuant to the Commission's *Report and Order* issued in Case No. ER-2008-0093 on July 30, 2008, effective August 9, 2008.

Since the filing of the compliance tariff sheets on August 6, 2008, and with regard to the tariff sheets designed to implement the fuel adjustment clause ("FAC") authorized and approved by the Commission in its *Report and Order*, it was discovered that a plus sign was used instead of a minus sign in the FAC formula with regard to the off-system sales margin. There were also certain capitalization and numbering errors discovered.

Accordingly, Empire hereby withdraws the four FAC tariff sheets (PSC Mo. No. 5, Sec. 4, sheet numbers 17, 17a, 17b, and 17c) filed on August 6, 2008, and submits new tariff sheets bearing the same sheet numbers. These FAC tariff sheets bear an issue date of August 8, 2008, and an effective date thirty days thereafter (September 7, 2008). Empire, however, requests that these tariff sheets designed to implement the FAC authorized and approved by the *Report and Order* be permitted to take effect for service rendered on and after September 1, 2008. Empire makes this requests for good cause shown, all as explained in greater detail in the Supplemental Motion for Expedited Treatment which is being filed herein. The subject revised tariff sheets are as follows:
