STAFF MEMORANDUM AND RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission, by and through the Commission's General Counsel, and hereby advises the Commission that it should approve the Tariff Sheets filed by Kansas City Power & Light Company (KCPL) to revise its Net Metering Program to comply with the revised "Net Metering and Easy Connection Act," § 386.890, RSMo Supp. 2007, and also grant KCPL a variance from the Commission's current and unrevised Net Metering Rule, 4 CSR 240-20.065, to avoid any conflict between the tariff, which complies with the "Net Metering And Easy Connection Act," § 386.890, RSMo Supp. 2007, and the Commission's current rule, which does not.
