These tariff revisions replace the previous Business Energy Efficiency Programs which expired on September 30, 2011. The tariffs in this filing are intended to provide interim Business Energy Efficiency Programs while the Company prepares to file more long term programs under the Missouri

Energy Efficiency Investment Act (MEEIA) early next year. These tariffs include an expiration date of June 30, 2012, but may be extended beyond that date.

Advance draft copies of this filing and supporting information have been discussed with the Missouri Public Service Commission (Commission) Staff, the Office of Public Counsel (OPC), and the Department of Natural Resources (DNR).
