**MODIFICATION OF JOINT PETITIONERS' APRIL 8 RESPONSE TO  
THE COMMISSION'S APRIL 2 ORDER DIRECTING FILING**

1. The Commission issued its Order Directing Filing on April 2, 2013, and Joint Petitioners timely filed their responsive pleading on April 8, 2013. In paragraph 10 of that pleading, Joint Applicants suggested that, if the Commission ordered a procedural schedule, their Direct Testimony be filed April 22, 2013, and that Staff/OPC/Intervenor Rebuttal Testimony be filed May 22, 2013.
2. Joint Applicants modify that request, asking that Joint Applicants' Direct Testimony be due April 25, 2013, and Staff/OPC/Intervenor Rebuttal Testimony be due May 24, 2013.
3. Changes in the schedules and availability of the witnesses since the April 8 filing necessitated this request.

**WHEREFORE,** Joint Applicants request the Commission, to the extent the Commission believes it is necessary to establish a procedural schedule, to adopt the schedule proposed by Joint Applicants on April 8, as modified above.


