## RESPONSE OF PUBLIC COUNSEL TO ORDER DIRECTING FILING

COMES NOW the Office of the Public Counsel and for its Response to Order Directing Filing states as follows:

- 1. On August 31, 2011, Jimmie E. Small filed a complaint against Union Electric Company d/b/a Ameren Missouri UE.<sup>1</sup>
- 2. On October 26, 2011, the Commission issued an order directing the parties to state "what remedy, if any, the Commission has authority to grant Mr. Small in the event he prevails in his complaint." The Commission set a deadline of November 7, 2011 for this filing.
- 3. Although the filings in this case are voluminous and appear to contain much information that may not be germane to the central issues, it appears that there are at least two substantive issues that will be presented to the Commission and that the Commission may be able to properly rule upon: 1) whether Mr. Small's electric service in Kirksville was disconnected in 2006 in accordance with applicable statutes, rules and tariffs; and 2) whether

charges allegedly incurred after the 2006 disconnection have been improperly charged to Mr. Small's account.

4. A finding in Mr. Small's favor on either or both of these issues could provide a meaningful remedy to Mr. Small.
