AN ORDINANCE

FINDING THAT BLIGHTED, INSANITARY AND UNDEVELOPED INDUSTRIAL AREAS EXIST IN KANSAS CITY, MISSOURI AND THAT DEVELOPMENT OF SUCH AREAS IS NECESSARY; APPROVING THE EXERCISE BY THE PLANNED INDUSTRIAL EXPANSION AUTHORITY OF KANSAS CITY, MISSOURI OF THE POWERS, FUNCTIONS AND DUTIES AUTHORIZED BY SENATE BILL NO. 362 PASSED BY THE 74TH GENERAL ASSEMBLY OF THE STATE OF MISSOURI AND REQUESTING THE MAYOR TO APPOINT COMMISSIONERS.

WHEREAS, the 74th General Assembly of the State of Missouri passed Senate Bill No. 362 and said bill was approved by the Governor on August 16, 1967 and became effective on October 13, 1967, and

WHEREAS, Section 3 of said Act created in Kansas City, Missouri a public body, corporation and politic, known as the "Planned Industrial Expansion Authority" of Kansas City, and

WHEREAS, under the provisions of Section 3(1) of said Act, said Authority may not transact any business or exercise the powers conferred upon it under the terms of the Act until the Council of Kansas City shall approve by ordinance, as in said Act provided, the exercise by said Authority of the powers, functions or duties of an authority under said Act, and

WHEREAS, the Council finds that there exists in Kansas City one or more blighted, insanitary or undeveloped industrial areas as defined in said Act, and

WHEREAS, the Council finds that the development of such area or areas is necessary in the interest of the public health, safety, morals or welfare of the citizens of Kansas City, Missouri, NOW, THEREFORE,


BE IT ORDAINED BY THE COUNCIL OF KANSAS CITY:

Section 1. As required by Senate Bill No. 362 passed by the 74th General Assembly in the State of Missouri, approved by the Governor on August 16, 1967 and duly becoming an effective law on October 13, 1967, approval is hereby given to the exercise in Kansas City, by the "Planned Industrial Expansion Authority" of Kansas City, of the powers, functions and duties of an authority.

Section 2. That the Mayor be and he is hereby requested to appoint 25 commissioners of the "Planned Industrial Expansion Authority" of Kansas City as authorized by Section 4 of said Senate Bill No. 362.
